*Mizrahi Tefahot Bank Ltd. (the "Bank") reports hereby that on May 19, 2026 the Bank was served a petition to approve a class action, filed against it to the District Court in Tel Aviv (the "Petition").*

*The Petition alleges the existence of five (5) systemic failures in the way that data is being presented by the Bank's online securities trading digital platforms, which, allegedly, deny customers the ability to obtain reliable information, understand the current state of their accounts and properly perform trading activities, in violation, allegedly, of applicable law and in unjust enrichment.*

*The class members were defined as all the customers that made use of the Bank's Internet website and/or application, in their Hebrew or English versions, or the Bank's securities trading interfaces, that were exposed, through such use, to representations, data or displays provided by the Bank and/or experienced one or more of the failures described in the Petition.*

*The petitioners assessed the complaint amount at about NIS 522 million.*
