Nature of the Event: *Petition to approve a class action concerning the manner of trust account management*

Mizrahi Tefahot Bank Ltd. (the "Bank") respectfully reports hereby that on June 21, 2026 the Bank was served a petition to approve a class action, filed against it to the District Court in Tel Aviv (the "Petition").

The Petition subject matter concerns the manner of management of specific trust accounts and general trust accounts.

The petition claims that the Bank allegedly failed in risk management, supervision and monitoring activity in trust accounts managed by it, while allowing the trustees of these accounts to operate without restrictions, thereby causing financial and/or non-financial damage to the beneficiaries.

It is claimed that by its conduct the Bank allegedly violated its fiduciary, care, supervision, risk management and statutory duties imposed upon it in the management of trust accounts.

The petitioners set the complaint amount at NIS 1 billion.
