Below are the directors' decisions in accordance with Regulation 37(a)(1) of the Securities Regulations (Periodic and Immediate Reports), 5730-1970:

- The proposed dividend distribution does not have a material impact on the bank's financial situation. See below for details of the revenue balance.
- The balance of the corporation's revenues as defined in Section 302 of the Companies Law, prior to the proposed distribution, amounts to a total of ILS 19,942 million.
- The balance of the corporation's revenues as defined in Section 302 of the Companies Law, after the proposed distribution, amounts to a total of ILS 19,589 million.
- The impact of the proposed distribution on the equity structure was examined and the Board
 of Directors estimated that the results of the bank's activity in the year following the
 dividend distribution shall be such that the capital adequacy ratio and the leverage ratios
 shall be no less than required.

Furthermore and in addition to the aforesaid:

- There is no concern that the dividend distribution might prevent the bank from complying with its current and expected commitments.
- The proposed distribution is out of the revenues, as defined in the Companies Law.
- The bank complies with additional regulatory limitations set by the Supervision of Banks, including the provisions of the Proper Conduct of Banking Directive no. 331 regarding "dividend distribution by banking corporations", as well as capital adequacy limitations, leverage limitations and other limitations.

In view of the aforesaid, it is evident to the board of directors that there is no impediment to distribute a dividend in the sum of ILS 353.4 million, which constitute 30% of the net profit for the third quarter of 2022, and decided to approve said distribution in view of the results of the activity of the Bank in this period.

It is hereby clarified that the dividend distribution described above in this report is not to change the bank's updated dividend policy (as published on February 27, 2018, reference no. 2018-01-015753).
