In accordance with Article 11C(a)(4) of the Banking Ordinance, 1941, the Bank is hereby publishing a preliminary notice regarding its intention to convene a general annual meeting of the Bank's shareholders (hereinafter: "Annual Meeting"), upon the agenda of which, inter alia, is the confirmation of the reappointment of Mr. Moshe Vidman as a director at the Bank, subject to the Supervisor of Banks not announcing his objection to said appointment or announcing his consent thereto.

In this regard, it is noted that further to that which was detailed in the immediate reports published by the Bank on November 16, 2022 (in Section 3.2.4) and on December 21, 2022 (ref nos. 2022-01-137905 and 2022-01-153916, respectively), the Supervisor of Banks notified the Bank that he would allow the continuation of Mr. Vidman's tenure on the Bank's Board of Directors, such that it would terminate, at the latest, on June 15, 2024, and that until this time, the Bank will act to find and appoint another Chairman for the Bank.

A notice regarding the convening of the Annual Meeting will be published separately, at least 21 days after the publication of this preliminary notice.

This preliminary notice will also be submitted to the Supervisor of Banks at the Bank of Israel.
