*Mizrahi Tefahot Bank Ltd (the "Bank") hereby reports that further to the Bank's immediate report from March 22<sup>nd</sup>, 2018 (reference 2018-01-022860) and Section c.10(e) in Note 26 to the Bank's financial reports for December 31<sup>st</sup>, 2018, in the matter of an appeal submitted over a verdict granted on March 1<sup>st</sup>, 2018 by the Tel Aviv-Jaffa District Court, rejecting the applications to approve a class action lawsuit served against the Bank and others, and consolidated, in the matter of allegedly unlawful commission collections with respect to the conversion and delivery of foreign currencies, without an appropriate disclosure (the "Appeal"), on April 1<sup>st</sup>, 2019, the Supreme Court granted a verdict in which the Appeal was rejected, charging the applicants with expenses.*
