Re: Organizational Structure Change and Appointments

Mizrahi Tefahot Bank Ltd (hereinafter: the "**Bank**") hereby announces that on December 12, 2019, the Bank's Board of Directors approved changes to the organizational structure and appointments at the Bank, as detailed below:

- On December 31, 2019, Ms. Rita Rubinstein will retire, ending her tenure as deputy CEO and head of the Human Resources and Administration Division. As of January 1, 2020, said division's responsibilities will expand so as to entrust it with all of the Bank's resources and administration, and its name will be changed to the "Human Capital, Resources and Operations Division". The division will be headed by Mr. Nissan Levi, deputy CEO, who currently serves as the head of the Planning, Operations and Customer Assets Division.
- 2. The Planning, Operations and Customer Assets Division will be eliminated in such manner that its various units, which are charged with various resources or operations will be controlled by the Resources and Operations Division, while the units responsible for customer assets will be transferred to the Retail Division (financial consulting and Etgar Investment Portfolio Management from the Mizrahi Tefahot Group Ltd) and the Financial Division (provident fund operations and the Mizrahi Tefahot Trust Company Ltd), respectively.

The Planning and Economics Department will be transferred under the Accountancy Division, the name of which will be changed to the "Information and Financial Reporting Division", which will coordinate all aspects of information, its analysis and financial reporting.

- 3. Ms. Maya Feller, Bank secretary, has announced her intention to end her work at the Bank and retire. The end date of her tenure has yet to be determined.
- 4. Mr. Ofer Horwitz, who in his current position serves as personal assistant to the Chief Executive Officer, having previously held various positions at the Bank, will be appointed as officer, Bank secretary and head of the Bank Headquarters, a new unit established under the Chief Executive Officer, which will coordinate the work of the Bank's secretariat and headquarters.
