Mizrahi Tefahot Bank Ltd. hereby reports as follows:

On February 16, 2016, an application to approve a class action lawsuit was delivered to the Bank, filed in the District Court in Tel Aviv, against the Bank, Bank Hapoalim Ltd, Bank Leumi Ltd, Israel Discount Bank Ltd and the First International Bank of Israel (hereinafter: "Respondents").

The subject of the application is alleged discrimination in services to university student groups due to their age, which thus allegedly breaches the Prohibition of Discrimination in Products, Services and Entry into Places of Entertainment and Public Places Law 5760-2000 as well as the Banking (Service to Customer) Law 5741-1981 (hereinafter: "Banking Law").

According to the applicant, this is a sweeping policy of all the Respondents, in which it was decided to exclude the "non young" population from the students benefits plan and/or the possibility to open an account with student terms, by setting an age ceiling for receiving student benefits.

The applicant wishes to establish under the Class Action Suit Law that the action shall be filed on behalf of all students discriminated against due to their age compared to younger students, and were denied student benefits by the Respondents over the past seven years (under grounds according to the Banking (Service to Customer) Law 5741-1981) or as of July 15, 2014 (under the amendment to the Prohibition of Discrimination Law).
